

The Service:

Stasis Publishing Arizona provides Internet server space for its members for a fee for the express purpose of providing http content to the general public. In addition to this our members may also receive Internet mail after taking the steps to set up the mail boxes and forwarding accounts. Users are permitted to access their web space via FTP or Frontpage to upload files for their web sites.

Cost and Payment For The Service:

Current pricing information may be obtained from our website at <http://www.stasisaz.com>. By accepting this agreement you agree to pay the current rate for the service as indicated on the web site. You agree to commit to a minimum of two (2) years hosting. Any accidental overcharges will be credited to your account or refunded at your discretion. You agree to pay Stasis Publishing Arizona promptly by check or money order yearly. Stasis Publishing Arizona may set up a debit payment system in the future and, if you choose this payment method, Stasis Publishing Arizona has the right to debit the account for the service until, after the two year initial hosting, you cancel the service in writing, understanding that it takes 48 hours for such cancellation to take affect. You agree that if payment is not paid for any reason by you, your bank or credit card company, that we will contact you and you will be given 48 hours to respond. You agree that after this time your account may be disabled until payment is made. If your account is disabled for this reason, you agree to pay \$40.00 re-enabling fee. You agree that refunds to your account after termination whether by Stasis Publishing Arizona or by the client, allowed only after the two year minimum, will cost a \$10.00 charge.

Refunds:

After the two year minimum, Stasis Publishing Arizona will refund fees for hosting for web accounts if the account is removed from the network and written notification (email) is sent to Stasis Publishing Arizona asking for the refund and terminating the account (it takes 48 hours for termination to come into affect). This is paid pro-rata and there is a \$10 fee for refunds. All clients acknowledge the setup fee is non-refundable.

Use of the service:

The use of any of our servers is to be bound by the terms of this agreement, the Stasis Publishing Arizona web site at <http://www.stasisaz.com>, and other information that is made available to you.

You may not in the use of the service break any state, local or federal laws. You agree that Stasis Publishing Arizona may remove any information that it finds or is reported to be unlawful. You also understand that Stasis Publishing Arizona may terminate your account if it feels that your information is unlawful. You may not in anyway send unsolicited bulk e-mail, post to news groups in way that do not conform with the rules of that group that can be traced back to our network, your website or you. By doing so you automatically terminate, without refund for the initial two year period, your service with Stasis Publishing Arizona,. You may not display content from your website promoting SPAM, bulk email or illegal websites or illegal activities.

Availability of the service:

The Internet is a complex network of equipment and for that reason the service may not be available to you at all times. Stasis Publishing Arizona will do everything in its power to maintain availability however a certain amount of

down time can be expected. In no way shall Stasis Publishing Arizona be held liable for any interruption in service for any cause. Changes:

The agreement and the service may change from time to time and will be posted at www.stasisaz.com or on this page 30 days before you will be bound by the new terms.

Termination:

Both Stasis Publishing Arizona and you have the right to terminate your service at any time by providing written notice via email. If you terminate the service it will take up to 48 hours before billing stops.

Legal Action:

Stasis Publishing Arizona cannot be held liable for any content posted by clients, or any damages you, your business or any other entity suffer as a result of downtime or termination of your account. Any legal action must be taken in the city of Prescott Valley, in the state of Arizona in the country of the United States.
